

## ADDENDUM FOR THE REGISTRATION OF DOMESTIC PARTNER FOR MEMBERSHIP PRIVILEGES

## REGISTRATION

The Club provides that members who are Domestic Partners (as defined below) may enjoy the same privileges of membership in the Club as members who are legally married. In order to obtain the same privileges of membership as granted to a legally married couple, the Club requires that both of the Domestic Partners execute this Addendum and the declaration attached as Exhibit A. A Domestic Partnership shall be any social union which meets the parameters contained in the attached declaration.

Each membership must have a Primary Member who will be the Club's primary contact and person ultimately responsible for the membership in the Club. The Primary Member will be the member who signs the Membership application to which this Addendum is attached. Both the Primary Member and the Domestic Partner will be jointly and severally liable for all amounts owed to the Club during all dates in which the Domestic Partner is registered pursuant to this addendum. In the Bylaws, Rules and Regulations, the Membership application and other documents related to the use of the Club, Primary Member will be synonymous with any and all references to the "Member" and the Domestic Partner registered pursuant to this addendum (the "Domestic Partner") shall be synonymous with any and all references to "Spouse" (as permitted by Federal and state law).

Notwithstanding the above, both parties must agree to be bound by the same terms and conditions as are applicable to "Members" and "Spouses", as provided for in the Bylaws, the Rules and Regulations and the Membership Application. The Primary Member should fill out the Membership Application and sign this Addendum and the Domestic Partner should fill out and sign this Addendum. The Club reserves the right to request documentation that demonstrates the relationship between the Domestic Partners. A Registered Domestic Partner may only be changed pursuant to this addendum once every year. The Club may charge a registration fee for changing such Registered Domestic Partner.

This Addendum may not be amended or modified, nor shall any waiver of any provision hereof be effective, except by an instrument in writing executed by the undersigned and the Club. This Membership Agreement shall be governed by and construed and enforced in accordance with the laws of the State of California, without giving effect to principles of conflicts of law.
